## EMPLOYMENT OPPORTUNITY

Long Lake #58 First Nation (LL58FN) community is located along the north shore of Long Lake along Highway 11 and approximately 300 kilometers northeast of Thunder Bay, ON. LL58FN is a member of the Anishinabek Nation and the Matawa First Nation Management Group. It has a large membership with the majority residing in the community and in Thunder Bay, ON.

## ENVIRONMENTAL MONITOR

The Environmental Monitor will participate in environmental assessment programs run by Greenstone Gold Mines (GGM) for its Hardrock Project near Geraldton, Ontario and serve as a member of the Joint LLFN-GGM Environmental Monitoring Committee. The Environmental Monitor is responsible for environmental monitoring activities associated with the project. Environmental monitoring duties include, but are not limited to, surface water, ground water, soil, vegetation, and fish sampling. The Environmental Monitor will participate in community consultation sessions to discuss and present environmental monitoring information along with GGM and third-party experts. The Environmental Monitor will report to LLFN and the Environmental Committee on monitoring activities and results on a regular basis.

### Duties and Responsibilities

- Observe and participate in GGM environmental monitoring activities such as:
  - Collecting samples (air, water, vegetation, soil, etc.).
  - Fish and wildlife counts.
  - Regulatory compliance (equipment inspections, water extraction/handling, soil handling, fuel spill management, waste management, wildlife management, etc.).
- Attend monthly Environmental Monitoring meetings, Environmental Committee meetings and provide necessary updates and reports on meeting outcomes/issues.
- Review reports and provide recommendations on project-specific issues.
- Monitor and follow-up on LLFN environmental monitoring and mitigation concerns.
- Participate in discussions on the Terms of Reference for the Environmental Monitoring Committee.
- Identify and locate environmental and cultural heritage resources.
- Participate in all required training sessions (seminars, workshops, etc.).
- Coordinate flow of information between related internal and external parties, as appropriate.
- Provide advice/recommendations on emerging trends.
- Perform general administrative duties as required.
- All other related tasks, as assigned.

## Accountability

The Environmental Monitor is accountable to, and is under the day-to-day supervision of, the Economic Development Manager.

## Education and Skill Requirements

### *Education and Experience*

- Grade 12 diploma or equivalent. College diploma or university degree preferred (Mathematics, sciences or computer studies would be an asset)
- Experience in a mining, mineral exploration or industrial environment is an asset.
- Experience conducting environmental sampling is an asset.
- CPR A and/or Boater's License is an asset.

### *Mandatory Requirements*

- Must be a member of Long Lake #58 First Nation.
- Driver's License and access to personal vehicle is required.
- Must provide an up-to-date Criminal Reference Check.

### *Other Desirable Skills*

- Ability to follow and maintain detailed and accurate records, documentation, and policies.
- Ability to work collaboratively with a team and individually with minimal supervision.
